Bold Items are essential. We advise applicants that the failure to submit such documentation may result in refusal of the application, as the onus is on the applicant to demonstrate that they meet the requirements of the relevant rules. The ECO's decision will be made on the basis of the evidence supplied. It is paramount that ECO's understand the reasons for your application as well as your personal circumstances. All documents submitted as evidence of points claimed must be submitted in their original format and must be supported by notarised translations. Checklist:
